How the National Drowning Prevention Alliance (NDPA) and Clarion Safety Systems Are Partnering To Promote Water Safety for Class "C" Aquatic Facilities

### The NDPA Seal of Safer Pool Practices Program

The Seal of Safer Pool Practices program, developed by the NDPA with input from the Independent Pool and Spa Service Association, provides best practice safety guidelines for aquatic facilities, following recommendations based on the Safer 3 Water Safety Foundation's model for reducing drowning incidents. The goal: creating a safer experience for patrons at class "C" aquatic facilities — including hotels, motels, apartments, condominiums, property owner associations, and multi-family owned pools — and to help reduce the risks of water-related incidents, as well as resulting costs to facilities.

### Signage Requirements

The Seal of Safer Pool Practices program includes a guideline regarding the necessity of posting best practice pool safety signs to effectively communicate water hazards and risks. As part of its program, the NDPA recommends Clarion Safety System's pool safety sign system of comprehension tested signs. To meet facilities' pool specifications, two sign system options are available to choose from: one for guarded pools and another for unguarded pools. There is also an opportunity to select materials for indoor or outdoor pools.
