Clarion P material is our Premium Polyester indoor label material. It is primarily used for product safety labeling but is suitable for a variety of applications where high performance is a requirement. Such applications include but are not limited to barcode labels and rating plates, property ID and asset labeling, warning, instruction and service labels, and nameplates for durable goods. The use of the 3M standard polyester overlaminates provides an exceptional degree of humidity, chemical, and solvent resistance.
