These custom labels and signs include a 'Warning' header and symbol, as well as the Proposition 65 warnings website, www.P65Warnings.ca.gov, needed for compliance. Users of the tool follow two simple steps of choosing their word message and size/material specifications, and can then send their label or sign directly to print.
